LANCASTER PRESCHOOL SCHOLARSHIP APPLICATION

It is the intent of the Lancaster Preschool Board to allocate funds to be used for preschool tuition scholarships, contingent upon funding availability. The purpose of our scholarship is to provide a positive preschool experience for children whose family cannot afford full Lancaster Preschool tuition fees.

Scholarship Funding Parameters:

Scholarship funds will be distributed throughout the academic year to eligible families after review by the preschool Board. Funds awarded must be used to provide preschool tuition assistance for Lancaster Preschool from families with incomes at or below 200% of the poverty level (based on the most recent guidelines released, see below for current poverty income levels).
